DECISION

No 1501-N of 24 December 2009

ON ESTABLISHING THE CORRESPONDENCE OF THE MILITARY TITLES CONFERRED IN THE ARMED FORCES, IN THE NATIONAL SECURITY BODIES, OF THE TITLES OF THE PENITENTIARY SERVICE, OF THE JUDICIAL ACTS COMPULSORY ENFORCEMENT SERVICE, OF THE CLASS RANKS OF THE PROSECUTOR'S OFFICE, AS WELL AS OF THE TITLES IN THE RESERVE WITH THE TITLES OF THE POLICE

Pursuant to the second paragraph of Article 7(2) of the Law of the Republic of Armenia "On police service", the Government of the Republic of Armenia decides to:

- 1. Define the correspondence of the military titles conferred in the Armed Forces, in the National Security Bodies, of the titles of the Penitentiary Service, of the Judicial Acts Compulsory Enforcement Service, of the class ranks of the Prosecutor's Office, as well as of the titles in the Reserve with the titles of the Police, pursuant to the Annex.
- 2. Repeal the Decision of the Government of the Republic of Armenia No 1420-N of 1 September 2005 "On establishing the correspondence of the military titles conferred in the Armed Forces, in the National Security Bodies, of the special titles of the Penitentiary Service, of the class ranks of the Prosecutor's Office, as well as of the titles in the Reserve with the titles of the Police".
- 3. This Decision shall enter into force on the day following its official publication.
