**DECISION**

**ON THE PROCEDURE FOR MAINTAINING A CENTRALISED REGISTRY  
(REGISTER) OF ECONOMIC OPERATORS HAVING A DOMINANT POSITION**

Having regard to Article 6(5) and Article 19(1)(g) and (i) of the Law of the Republic of Armenia on the Protection of Economic Competition, Article 72(1)(1)(b) of the Law of the Republic of Armenia on Legal Acts, the State Commission for the Protection of Economic Competition of the Republic of Armenia **has decided to:**

1. Approve the procedure for maintaining a centralised registry (register) of economic operators having a dominant position as provided for in the Annex.
2. Repeal the decision No 84-No of 25 October 2002 of the State Commission for the Protection of Economic Competition of the Republic of Armenia on the procedure for maintaining a centralised registry (register) of economic operators having a dominant position in commodity market.
3. This decision shall enter into force on the tenth day following its official publication.

**PROCEDURE**

**FOR MAINTAINING A CENTRALISED REGISTRY (REGISTER) OF ECONOMIC OPERATORS HAVING A DOMINANT POSITION**

1. This procedure defines the procedure for maintaining a centralised registry (register) of economic operators having a dominant position in commodity market (hereinafter referred to as “the Registry”).
2. The Registry is a document (book) containing information provided for by this Procedure regarding economic operators having a monopolistic or dominant (hereinafter referred to as “dominant”) position (Form 1 attached).
3. The Register must be binded and sealed, and the pages must be numbered. The number of pages shall be approved by the head of the responsible subdivision of the Commission Staff and shall be sealed of the Commission. The central part of the cover page (binding) of the Registry shall contain the following entry: “Centralised Registry (Register) of Economic Operators Having a Dominant Position”.
4. Information in the Registry shall be recorded by means of making a corresponding entry. Changes in information shall be recorded in the corresponding line on the reverse side of the relevant page of the Registry.
5. The entry in the Registry shall be recorded without corrections, abridgements and leaving incomplete lines, in a clear and legible handwriting.
6. Correction of an entry in the Registry shall be made by enclosing the wrong entry into brackets and inserting the correct (amended) entry on the same page, accompanied by the signature of the head of the responsible subdivision of the Commission Staff, as well as the year, month, date (hereinafter referred to as “the date”) of the correction.
7. The Commission shall create and maintain an electronic version of the Registry.
8. Each page of the Registry shall contain the following information on economic operator having a dominant position in the following sequence:
  - 1) reference number of the entry,
  - 2) name of economic operator (name and surname in case of a natural person),
  - 3) registered office of economic operator (including place of business in case of doing business elsewhere) (place of residence in case of a natural person),
  - 4) contact information (telephone, fax, e-mail), if available,
  - 5) name of commodity market,
  - 6) product boundary of commodity market,
  - 7) geographical boundary of commodity market,

- 8) volume of sales (purchase) of product by the economic operator within the volume of the commodity market,
- 9) share of the economic operator in the volume of the commodity market (%),
- 10) the number and the date of adoption of the decision of the Commission on registering the economic operator in the Registry,
- 11) where the Commission takes a decision to remove the economic operator from the list of economic operators having a dominant position in commodity market, the number of the decision and the date of its adoption.

9. In cases where a change in information mentioned in points 8(2) to 8(4) of this Procedure occurs or an economic operator recorded in the Registry is reorganised (if this does not lead to the loss of dominant position), an entry fixing the change together with the date when the entry was made shall be recorded in the corresponding line on the reverse side of the relevant page of the Registry.

10. Where a change in information mentioned in point 8(8) and 8(9) of this Procedure occurs (if this does not lead to the loss of dominant position), an entry fixing the change shall be recorded in the corresponding line on the reverse side of the relevant page of the Registry indicating the number of the Commission decision and its adoption date.

11. An economic operator shall be recorded in the Registry and in case of losing dominant position its registration shall be deleted by the Commission decision.

12. The Registry shall contain information (data) approved by the relevant decision of the Commission.

13. The entry shall be recorded in the Registry within the period of five days from the day of adoption of the decision of the Commission.

14. Upon request of an economic operator recorded in the Registry, the Commission must, within a period of seven days, provide an excerpt from the Registry on information related to the economic operator concerned.

15. Every six months economic operators listed in the Registry must submit to the Commission information envisaged in Forms No 2, No 3, No 4 and/or No 5 (the forms are attached) on the volume of products sold or acquired by them respectively in the relevant commodity market, the structure of costs and price developments (including relevant reasons in case of a change in prices) as of July 1 of the current year and January 1 of the next year till August 15 of the current year and February 15 of the next year respectively. The Commission shall provide (send) the forms envisaged by this point to economic operators by July 15 of the current year and January 15 of the next year respectively.
