For the purpose of establishment and functioning of the single services market within the framework of Eurasian Economic Union in accordance with paragraph 40 of the Protocol on trade in services, incorporation, activities and investments (Annex 16 to the Treaty on the Eurasian Economic Union of 29 May 2014), as well as taking into account the information provided by the Eurasian Economic Commission, the Supreme Eurasian Economic Council has decided at the level of heads of states to:

1. Approve the attached list of sectors (sub-sectors) of services in which the single services market within the framework of Eurasian Economic Union functions.
2. To the Council of the Eurasian Economic Commission — to create working groups in the specified sectors (sub-sectors) of services with the purpose of ensuring the functioning of the single services market.

3. This Decision shall enter into force on the date of entry into force of the Treaty on the Eurasian Economic Union of 29 May 2014.

- (1) general construction works for erection of one- and two-dwelling residential buildings, multi-dwelling residential buildings, non-residential buildings and industrial buildings;

- (2) works for construction of warehouses and industrial buildings of processing enterprises, light industrial buildings and agricultural buildings;
- (3) works for construction of buildings used for commercial and administrative purposes, offices, banks, parking garages, petrol stations, service stations, shopping malls, air, road or railway terminals;
- (4) works for construction of other non-residential buildings including works for building of:
 - public cultural and entertainment buildings, including cinemas, theatres, concert halls, dance halls and nightclubs;
 - hotels , motels, inns, hostels, restaurants and similar buildings;
 - educational buildings, including schools, colleges, universities, libraries, archives and museums;
 - healthcare facilities, such as hospitals and sanatoria;
 - sports and recreational buildings, including ice rinks, gymnasias, indoor tennis courts, general-purpose sports halls, boat sheds, boxing rings, etc.
 - swimming pool structures;
 - non-residential buildings not included in other categories;
 - related to building of foundations for sports grounds in the sports and recreational facilities, including ice rinks, gymnasias, and indoor tennis courts.

General construction works for building of civil engineering projects (roads, industrial and sport facilities and other projects) (except for services related to particularly dangerous and technically complex capital construction projects, as well as associated with preservation of cultural heritage property)

(historical and cultural monuments)) (from CPC 542, 54210, 54220, 54230, 54241, 54242, 54251, 54252, 54260, 54270 and 54290) <2> in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) construction works for building motorways (except for elevated motorways), streets and roads;

for construction of foundations of motorways (except for elevated motorways), highways, streets, other vehicular and pedestrian ways and open car parks;

for creation or renovation of asphalt, concrete and similar pavings of roads and car parks;

for establishment of pedestrian crossings, traffic calming devices, bicycle tracks, etc.

construction works for installation of restrictive barriers and median barriers to prevent clashes, low dividing walls and road signs;

for marking traffic lanes and pedestrian crossings, installation and maintenance in working order of traffic indicators;

road maintenance and repair;

painting works for marking the roads, car parks and similar surfaces;
- (2) general construction works for erection of sports and recreational facilities:

for building structures for stadia and other grounds for sports played in the open air such as football, baseball, rugby, track and field sports, motor racing, cycle racing and horse racing;

for construction other than buildings (flat-works) for stadia and other grounds for sports played in the open air such as football, baseball, rugby, track and field sports, motor racing, cycle racing and horse racing;

for creation of recreational facilities, including beach installations, mountain refuges, parks and park facilities;

(3) general construction works for erection of other engineering facilities, not included in other categories.

3. Assembly and erection of buildings from prefabricated structures and equipment installation works (except for services related to particularly dangerous and technically complex capital construction projects, as well as associated with preservation of cultural heritage property (historical and cultural monuments)) (from CPC 54400 and 546) <2> in regard to works related to:

installation, assembly and erection of buildings from prefabricated structures;

installation, assembly and erection of other facilities from prefabricated structures and precast elements;

installation of all types of street furniture.

4. Building completion and finishing works (except for services related to particularly dangerous and technically complex capital construction projects, as well as associated with preservation of cultural heritage property) (historical and cultural monuments)) (from CPC 547, 54710, 54720, 54730, 54740, 54750, 54760, 54770 and 54790) <2> including:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

(1) glazing works;

installation works with cladding glass, mirror walls and other glass products;

closed-in work such as window glass installation works;

(2) plastering works:

interior and exterior works for wet plastering and application of lathing materials;

dry walling works, including works with application of wallboard generally of gypsum;

(3) painting works;

of interior building premises and similar services;

of exterior building surfaces (principally for protection);

painting of railings, gratings, doors and window frames of buildings, etc.

painting of other engineering structures;

paint removal works;

(4) floor and wall tiling:

construction works related to laying ceramic, concrete or stone wall tiles, floor tiles or flagstones on buildings and other structures;

decorative covering of exterior walls of buildings with ceramic materials, stone, brick, etc.

(5) other floor laying, wall covering and papering;

laying of carpeting, linoleum and other flexible floor coverings, including related finishing works;

installation of door and window frames and of doors, windows, shutters, folding shutters, garage doors, etc. made of any kind of material;

installation of verandas and conservatories;

carpentry and joinery works with any material other than metal;

installation of interior staircases, construction of wall cupboards, installation of fitted kitchen appliances;

cleaning of outer walls by steam cleaning or sandblasting;

acoustic works with application of acoustic panels, tiles and other materials to interior surfaces of walls and ceilings;

construction works with poured-in-place terazzo and interior marble, granite, slate work;

repair and technical maintenance work;

building completion and finishing works not included in other categories.

5. Pre-construction works, special construction works, building demolition works and renting of equipment for construction, with operator (except for services related to particularly dangerous and technically complex capital construction projects, as well as associated with preservation of cultural heritage property) (historical and cultural monuments)) (from CPC 543, 54310, 54320, 54330, 54341, 54342, 54511, 54512, 54521, 54522, 54530, 54540, 54550, 54560, 54570, 54590 and 54800) <2>:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

(1) demolition of buildings and other structures;

(2) wrecking and demolition of streets and motorways;

(3) construction site formation and clearance;

(4) preparation of agricultural land;

(5) preparation of sites for subsequent construction works, including blasting and rock removal works, clearance, clearance of undergrowth;

(6) soil sterilisation;

- (7) drilling and boring and core extraction works for construction, geophysical, geological or similar purposes;
- (8) drilling horizontal wells for laying cables and drainpipes;
- (9) digging of drainages;
- (10) overburden removal and other development and preparation services of locations of mineral deposits and sites, including tunnelling, except for works related to oil and gas extraction;
- (11) excavation and earthworks:
 - large-scale earthworks, ground excavation, sloping formation, earthmoving in making embankments or cuttings, prior to construction of transport routes (roads, motorways, railways, etc.);
 - digging of trenches for utilities, urban drainage, various roadworks, etc.

 - other works on ground excavation and earthworks;
 - drilling of water wells, including special construction works related to drilling and sinking of water wells;
 - works for installation of water well pumps and well piping systems;

 - laying of the foundation, including special construction works for laying of foundation;

- (13) installation of roof frames, including construction works related to installation of roof frames;
- (14) roofing and waterproofing works;
construction works related to installation of any kind of roof coverings;

waterproofing works on flat roofs and roof terraces;
waterproofing works on the outside surfaces of facilities and other subterranean structures;

- (16) concrete works:
erection of high-strength concrete frames requiring specialised skills or application of special equipment because of their sizes or the methods used;
construction of domes and thin shells in concrete;

casting of concrete in formwork and other works generally making use of concrete (general foundations, foundation beams, raft foundations, stanchions, floors, etc.);

- (19) erection of scaffolds, involving erection and dismantling of scaffolds or working platforms, including renting of scaffolds and working platforms;
- (20) other special construction works, including works for construction of factory chimneys;
- (21) installation of refractory linings for furnaces;
- (22) construction works of ornamental heating appliances;
- (23) other special construction works, not included in other categories, for example: relocation of houses, asbestos removal works;
- (24) rental works related to construction equipment or demolition of buildings or civil engineering projects with operator, including services in the fields of leasing or renting of construction machinery and equipment without operator.
6. Engineering services (except for particularly dangerous and technically complex capital construction projects, as well as associated with preservation of cultural heritage property (historical and cultural monuments)) (from CPC 8334) <2> in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) carrying out design engineering and consulting;
 - (2) rendering services for architectural and design works.
7. Integrated engineering services (except for the services in regard to particularly dangerous and technically complex capital construction projects, as well as associated with preservation of cultural heritage property (historical and cultural monuments)) (from CPC 8331, 83342 and 83343) <2> related to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) residential and non-residential buildings, such as industrial, commercial or agricultural buildings, civil engineering projects;
 - (2) industrial enterprises, production processes and their automation;
 - (3) streets, roads;
 - (4) construction of sports and recreational facilities related to:
 - rendering engineering services for "turn-key" projects;
 - management for construction projects;
 - rendering consultancy services;
 - planning and surveying works;
 - engineering services rendered during construction and installation of equipment;
 - rendering of integrated engineering services.
8. Urban planning services (except for particularly dangerous and technically complex capital construction projects, as well as associated with preservation n of cultural heritage property (historical and cultural monuments)) (from CPC 83221, 83222, 83333) <2> including services on:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

the development of plans of land use;

site selection, control and utilisation of road systems and servicing of land parcels;

conducting research of environmental impact and economic assessment of urban development programmes;

the preparation of land parcel development plans, working drawings, technical specifications, cost estimates for land utilisation, sketches of terrain;

inspection of construction works.

9. Landscape architectural services (except for services associated with preservation of cultural heritage property (historical and cultural monuments)) (from CPC 83222) in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

(1) planning and design of aesthetic landscaping of parks, commercial and residential land parcels;

(2) preparation of land parcel development plans, working drawings, technical specifications;

(3) preparation of sketches of terrain;

(4) preparation of cost estimates for vegetation to be planted and creation of facilities such as walks, fences and parking areas.

10. Agricultural services (from CPC 861, 86110 and 86121), including services on:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) preparation of fields;
- (2) planting, cultivation <3> and fertilisation of crops;
- (3) control of pests <3>, causative agents of plant diseases and weed plants;
- (4) trimming of fruit trees and vines;
- (5) crop tending;
- (6) cotton ginning;
- (7) harvesting of crops;
- (8) provision of agricultural machinery with crew and operators;
- (9) services on ensuring production of farm animal husbandry such as sheep shearing, care and management of herds;
- (10) artificial insemination, grading of eggs, cleaning of agricultural premises;
- (11) accepting, clearing, drying, grading and preparation of agricultural production and its supply in primary market.

11. Forestry and logging services (from CPC 86140) including:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) forest tree nursery services;
- (2) services related to forestry production, such as transplanting, forest restoration, thinning, forest protection from pests and diseases, fire protection;
- (3) services related to wood production and logging, such as felling, cutting, debarking, transport of logs within the felling area.

12. Services related to operation of a hunting unit (from CPC 86130) in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) animal number control;
- (2) game breeding.

13. Wholesale trade services <4> (from CPC 611 and 612) <5> in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) activities of persons carrying out wholesale trade, purchasing goods in large quantities and selling them to other persons engaged in entrepreneurial activities, sometimes breaking down large batches of goods into smaller packages;
- (2) activities of commission agents, brokers on sale and purchase of primary commodities, auctioneers and persons carrying out wholesale trade or implementing commercial deals between purchasers and sellers on a fee or contractual basis;
- (3) activities of wholesale agents and brokers using electronic trading system;
- (4) activities of persons organising wholesale auctions other than wholesale trade.

14. Retail trade services <4> (from CPC 621 - 623) <5> in regard to services rendered by:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) by supermarkets and department stores;
- (2) by organisations organising retail auctions;

- (3) by specialised and commission stores;
 - (4) stores that accept orders of new goods by mail, telephone, e-mail or using other means of communication through delivery and (or) transfer of goods to the consumer (purchaser);
 - (5) through vending machines;
 - (6) through market stalls;
 - (7) through itinerant trade or retail chain of the producer through sales by commercial agents from retail warehouses on a fee for sale of goods and for marketing and advertising services;
 - (8) depending on actual utilisation or consumption of such goods or services;
 - (9) by commission agents holding negotiations on commercial deals in the sphere of retail trade on a fee or contractual basis;
 - (10) at electronic retail auctions.
15. Services of commission agents including broker services except for financial services provided for by section XVI of the Treaty on the Eurasian Economic Union of 29 May 2014 (from CPC 612) <5>.

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

16. Franchising services (from CPC 73340) <5>.

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

17. Services of hotels and public catering enterprises (except for sales (serving) of alcoholic beverages) (from CPC 63110, 63210, 63220, 63230 and 6330) <5> in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) provision of temporary accommodation and related services furnished by hotels, motels, guesthouses and similar temporary lodging places;
- (2) food preparation and related beverage serving furnished by restaurants, cafes and similar public catering enterprises providing full service of waiters to individual customers;
- (3) food preparation and related beverage serving furnished at hotels or other lodging places or in transport facilities;
- (4) provided by dining cars and buffet cars;
- (5) meal serving in establishments with partial or full self-service;
- (6) activities of canteens on providing food and beverages at a reduced price, in establishments for clearly defined group of persons who are linked by ties of a professional nature;
- (7) activities of enterprises specialised in food preparation and supply to private households on the premises or elsewhere, which may also include food serving at tables;
- (8) activities of enterprises, specialised in food preparation and its delivery to transport enterprises;
- (9) activities of enterprises, specialised in food preparation and its delivery to other enterprises or other institutions, including restaurants and canteens;
- (10) mobile catering and related beverage supply activities;
- (11) beverage supply services provided by bars, beer halls, night clubs, discotheques and similar establishments with or without an entertainment programme, including services provided by bars located in hotels or other temporary lodging places or in transport facilities.

18. Cargo handling services (from CPC 67190 and 64339) <6> in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) non-containerised cargo or passenger baggage handling;
- (2) activities of cargo terminal facilities for all modes of transport, including stevedoring related to non-containerised cargo of vessels at ports;
- (3) baggage handling at airports, at bus, rail or highway vehicle terminals.

19. Storage and warehousing services (from CPC 67290) <6> in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) grain storage;
- (2) other storage and warehousing services.

20. Cargo transport agency services (from CPC 67910) <6> in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) brokerage services on freighting of vessels;
- (2) cargo brokerage services;
- (3) cargo forwarding, including by transport service organisations or arrangement services on behalf of the shipper or the consignee;
- (4) aircraft space brokerage services;
- (5) cargo consolidation and break-bulk.

21. Other brokerage services, services on preparation and legalisation of transport documents, examination, weighing of cargo and other similar services <6>.

22. Technical maintenance and repair of the equipment of motor vehicles (from CPC 87141) <6> in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) engine overhaul, engine tune-up, carburettor repair and adjustment, steering gear repair and adjustment, suspension repair, brake repair and adjustment, transmission repair and adjustment, exhaust system repair, cooling system repair including water hose replacement and other technical maintenance and repair services of motor vehicles;
- (2) operations involving periodic inspections and inspections carried out by technical maintenance stations;
- (3) electrical system repair and accumulator battery charging for motor vehicles;
- (4) technical aid in case of an accident.

23. Maintenance and repair services of equipment, including personal appliances and household goods (except for sea craft and aircraft and other transport equipment) (from CPC 8715 and 87290) <6>.

24. Renting of cars and equipment without operator related to leasing and rental services (from CPC 73112, 73114, 73121-73123) of:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) motor vehicles without a driver designed for the transport of cargo;
- (2) motorcycles, motor homes and travel trailers without a driver;

- (3) passenger transportation vehicles;
 - (4) agricultural tractors and attached implements, seed and seedling planters, harvesting, cropping and sorting machinery;
 - (5) tractors for construction and earth moving works, road graders, steam-rollers, bulldozers, excavating machinery, front-end loaders, scaffolding without erection and dismantling, site huts;
 - (6) all kinds of office machinery and equipment, office furniture, safes.
25. Hiring of personal appliances concerning leasing and renting of all kinds of household appliances used for leisure activities (from CPC 73210).

26. Taxation services (from CPC 823) in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) advisory services;
 - (2) drawing up (filling in) of tax declarations;
 - (3) assisting enterprises in tax planning and preparing the documentation.
27. Software application services (from CPC 83142) in regard to :

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) carrying out of system analysis;
- (2) software development;
- (3) adaptation of existing software;
- (4) provision of advice and assistance in technical matters related to computer software;

- (5) conducting feasibility studies on the implementation of the system;
- (6) providing specifications for a database design;
- (7) providing guidance and assistance during the start-up phase of a new system;
- (8) providing specification to secure a database;
- (9) providing advisory services on proprietary software.

28. Data processing services (from CPC 84300 and 85960) in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) data input preparation;
- (2) data processing and tabulation;
- (3) leasing or rental of machine time (CPU-time) on the data processing system to third party, in time shared with other users.

29. Database services (from CPC 84300) in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) provision of information on web-sites;
- (2) provision of services on retrieval of data and other information from information resources, to all or limited number of users.

30. Services related to computer hardware, including services on technical maintenance and repair of computer hardware and related data preparation services (from CPC 83160) in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) provision of assistance to maintain computer systems (software) in good working condition;
- (2) technical maintenance, including testing to detect, locate and remove faults, improving programmes, providing up-to-date user manuals;
- (3) providing advice.

31. Advisory services related to installation of computer hardware.

32. Architectural consulting services (from CPC 83211) in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) providing assistance, consulting and recommendations concerning architectural and related matters;
- (2) preparation of preliminary studies addressing issues such as site philosophy, architecture, intent of development, climatic and environmental concerns, occupancy requirements, cost constraints, site selection analysis, design and construction scheduling.

33. Management consulting services (except for financial services provided for by section XVI of the Treaty on the Eurasian Economic Union of 29 May 2014) (from CPC 83111) in regard to:

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) rendering advisory, guidance and operational assistance concerning entrepreneurship policy and strategy and the overall planning, structuring and control of an organisation, determination of the organisational structure (decision- making system), that shall most effectively meet the objectives of the organisation;

- (2) strategic business planning, preparation of reports, development of programmes on improvement of profitability.
34. Management consulting services (except for financial services provided for by section XVI of the Treaty on the Eurasian Economic Union of 29 May 2014) (from CPC 83112-83114):

(edited by the Decision of the Supreme Eurasian Economic Council No 31 of 16 October 2015)

- (1) in matters of financial nature, including working capital and liquidity management, analysis of capital investments, development of systems of accountancy and budgetary controls, commercial valuation prior to mergers and (or) acquisitions;
 - (2) human resources management services, including:
 - audit of the work of personnel;
 - development of human resources;
 - (3) concerning methods of enhancing the image of the organisation and interactions with the authorities;
 - (4) strategy of the organisation on marketing and marketing operations related to one type or an array of the following types of services:
 - analysis and development of a marketing strategy;
 - development of customer service and pricing policy;
 - management and personnel training for sale of products;
