## THE SUPREME EURASIAN ECONOMIC COUNCIL

### **DECISION**

16 October 2015 No 30 Burabay city

On approval of the list of sectors (subsectors) of services, according to which the formation of a single services market within the framework of the Eurasian Economic Union will be carried out in accordance with the liberalisation plans (during the transition period)

In order to prepare the liberalisation plans provided for in paragraph 42 of the Protocol "On trade in services, the establishment, operation and implementation of investments" (Annex 16 to the Treaty on the Eurasian Economic Union of 29 May 2014), in accordance with paragraph 59 of Annex 3 to the Treaty of 10 October 2014 "On the accession of the Republic of Armenia to the Treaty on the Eurasian Economic Union of 29 May 2014", in accordance with paragraph 63 of Annex 1 to the Protocol of 8 May 2015 "On the conditions and transitional provisions for the application by the Kyrgyz Republic of the Treaty on the Eurasian Economic Union of 29 May 2014", particular international treaties forming a part of the law of the Eurasian Economic Union, and acts of bodies of the Eurasian Economic Union in connection with the accession of the Kyrgyz Republic to the Treaty on the Eurasian Economic Union of 29 May 2014 and having taken note of the information provided by the Eurasian Economic Commission, the Supreme Eurasian Economic Council decided:

1. To approve the attached list of sectors (subsectors) of services, according to which the formation of a single services market within the framework of the

Eurasian Economic Union will be carried out in accordance with the liberalisation plans (during the transition period).

- 2. To the governments of the member states of the Eurasian Economic Union by 1 April 2016, together with the Eurasian Economic Commission, to prepare plans for liberalisation specifying the specific terms (transition period) for the formation of a single services market in the sectors (subsectors) specified in the list approved in this Decision.
- 3. To the Eurasian Economic Commission by 1 July 2016 to submit for consideration by the Supreme Eurasian Economic Council the liberalisation plans specified in paragraph 2 of this Decision.
- 4. To the Council of the Eurasian Economic Commission in order to implement this Decision, to create working groups in the sectors (subsectors) of services specified in the list approved by this Decision.

of sectors (subsectors) of services, according to which the formation of a single services market within the framework of the Eurasian Economic Union will be carried out in accordance with the liberalisation plans (during the transition period)

- 1. General construction works for the construction of civil engineering facilities (tunnels, bridges, pipelines, communication lines) (from CPC 54210, 54220, 54230, 54241, 54242, 54251, 54252, 54260, 54310, 54320, 54330, 54342 and 54800)\* related to:
  - (1) construction works for the construction of railways and take-off runways at aerodromes:

for the construction of railways, including the works for laying ballast and rail track, the installation of points, connections and crossings, the creation of control and safety systems for railways, the construction of funiculars and cable railway;

for the construction of take-off runways at aerodromes, including taxiways and parkings for aircrafts;

for the renovation or repair of the railway track;

painting works for marking on roads, car parks and similar surfaces;

(2) general construction works for bridging, elevated highways, tunnels and underground roads:

for the construction of motorways, highways, railways and take-off runways at aerodromes;

works related to water;

for the installation of standing steel fittings;

(3) general construction works for the building of harbours, waterways, dams, irrigation systems and other water facilities:

for the construction of harbours, special berths for amateur ships, embankments, piers, berths, docks and similar port facilities;

for the construction of dams, canals, irrigation canals and aqueducts;

for the construction of locks, spillways, sluices, lifts, dry docks, slipways, barrages and other hydro-mechanical facilities;

works for dredging, rock and silt removal and other water related construction works;

underwater works (performed by divers, scuba divers and other technical specialists) and various engineering and hydrological services;

works for repair of harbours, waterways, dams, irrigation systems and other water facilities;

(4) general construction works for the building of main pipelines, including works for:

the construction of overland, underground or underwater main pipelines for the conveyance of oil or gas;

the construction of overland, underground or underwater pipelines, not intended for the conveyance of oil or gas;

the construction of main pipelines for water supply, drainage or rainwater disposal;

(5) general construction works for the construction of main communication lines and power (cable) lines, including works for:

the construction of main transmission lines,

including for railways;

construction of underwater or underground transmission main lines;

construction of overland main telecommunication lines;

construction of underwater or underground main telecommunication lines;

repair of main communication lines and power (cable) lines;

(6) general construction works for the construction of local pipelines:

for the construction of local water and sewage pipelines, including related auxiliary facilities, such as pumping stations;

for the construction of local pipelines for hot water supply;

for the construction of local gas pipelines and steam pipelines, including related auxiliary facilities;

(7) general construction works for laying of local cables and the creation of related facilities:

for the construction of local transmission lines, including auxiliary facilities such as transformer stations and substations for distribution within local boundaries;

for the creation of local communication lines, including auxiliary works, such as the construction of towers of transmitting devices;

for the construction of antennas and transformer stations for distribution within local boundaries;

construction works for laying underground cable TV lines;

for the repair of local cable lines;

(8) general construction works for the construction of mining and processing enterprises:

for the construction of all types of electrical power plants;

for the construction of mining and processing enterprises (for example, loading and unloading stations, shafts, chemical enterprises, iron foundries, blast furnaces and coke ovens);

for repair of the enterprises of mining and processing industry;

(9) pre-construction works, special construction works, demolition of buildings and rental of construction equipment with the operator (with the exception of services for particularly dangerous and technically complex capital construction projects, as well as related to the preservation of cultural heritage property (historical and cultural monuments)) related to:

excavation and earthworks services;

sewage system construction.

- 2. Services in engineering areas for particularly dangerous and technically complex capital construction projects and preservation of cultural heritage property (historical and cultural monuments) (from CPC 8335 and 8339)\* related to:
  - (1) carrying out design engineering and consulting;
  - (2) rendering services for architectural and design works.
- 3. Complex services in engineering areas related to motorways, streets, roads, railways, take-off runways, bridges, overland and underground highways, tunnels

- and harbours, waterways, water facilities, main pipelines, communication lines and energy lines, pipelines and cables and related facilities (from CPC 83312)\*:
- 4. Services in the field of urban planning for particularly dangerous and technically complex capital construction projects and the preservation of cultural heritage property (historical and cultural monuments) (from CPC 8322), including services in the field of:
  - (1) the development of draft land use programmes;
  - (2) the choice of location, control and use of road systems and maintenance of land parcels;
  - (3) conducting research related to environmental impacts and economic evaluation of urban development programmes;
  - (4) the preparation of plans of land parcels, working drawings, technical specifications, cost estimates of land planning, sketches of the terrain;
  - (5) for checking the progress of construction works.
- 5. Rental and leasing services for pleasure boats without operator (from CPC 73240).
- 6. Services in the field of advertising (from CPC 83610, 83620, 83631 and 83690) related to:
  - planning, organising and implementing advertising campaigns, writing a script for promotional films, planning (without production) of advertising objects or films;
  - (2) postal advertising;
  - (3) sales of advertising spaces, including books, brochures and booklets;
  - (4) selling by the publisher of the spaces for advertising in newspapers, magazines and periodicals;

- (5) selling advertising spaces on postcards, timetables, forms, posters and other printed materials supplied by the publisher;
- (6) sky advertising;
- (7) delivery of samples and other promotional products;
- (8) demonstration and presentation at the point of sale;
- (9) provision of such services by representatives directly to customers with the provision of information and (or) samples of goods;
- (10) promotion of the sale of goods and services.
- 7. Services in the field of audit (from CPC 82211 and 82212)\*.
- 8. Services related to real estate, owned or rented (with the exception of real estate intermediary services) (from CPC 72111, 72112, 72121, 72122, 72130 and 72212).
- 9. Services in the field of property evaluation (from CPC 72240 and 85990).
- 10. Services of travel bureaus and travel agencies (services of tour operators and travel agents) (from CPC 67811 and 67812), related to:
  - (1) the provision of travel tickets, placement and sale of package tours for remuneration or on a contractual basis;
  - (2) the organisation and carrying out of package tours (transportation of passengers and luggage, accommodation, sightseeing), as well as services provided during the package tour.
- 11. Technical testing and analysis services (laboratory and on site) (with the exception of works for the purpose of assessing (confirming) the compliance of products with the specified requirements) (from CPC 83561-83564 and 83569), related to the following services:
  - (1) testing and analysis of composition and purity;

- (2) testing and analysis of physical features;
- (3) testing and analysis of complex mechanical and electrical engineering systems;
- (4) technical inspection of road vehicles;
- (5) technical testing and analysis.
- 12. Services in geological, geophysical and other kinds of survey works for scientific advisory services in the field of geology, geophysics, geochemistry and other sciences related to the search for deposits of solid minerals, oil, gas and groundwater, with the exception of field works (from CPC 83510)\*.
- 13. Subsurface surveying services (from CPC 83520)\*.
- 14. Subsurface surveying services (from CPC 83530)\*.
- 15. Map-making services (from CPC 83540)\*.
- 16. Weather forecasting and meteorological services (from CPC 83550)\*.
- 17. Services related to the production and distribution of films and videos (from CPC 96121 and 96141).
- 18. Services for demonstration of video films (from CPC 96152).
- 19. Accounting and book-keeping services (from CPC 82213, 82219 and 82220) related to:
  - (1) compilation of financial statements based on information provided by the client (reliability of the reports is not guaranteed at the same time), income statements, balance sheets, balance sheet analysis and accounts (with the exception of services for drawing up declarations on business taxes);
  - (2) verification, evaluation and preparation of financial statements;

- (3) classification and registration of commercial transactions in monetary terms or another unit of measurement in accounting books;
- (4) services for the preparation (completion) of tax returns on business taxes, provided together with the preparation of financial statements.
- 20. Carrying out research work and implementation in the field of social sciences and humanities (from CPC 81210, 81220, 81230, 81240 and 81290).
- 21. Carrying out research work and elaboration of pilot projects in the field of natural sciences (from CPC 81110, 81120, 81130, 81140, 81150 and 81190) related to applied research in the fields of:
  - (1) heat, light, electromagnetism, astronomy;
  - (2) catalysis, fermentation, physiology and ecology of animals, plants and microorganisms;
  - (3) technology of casting, metallurgy, machinery, electricity, communications, ships, aircraft, civil engineering, construction, information;
  - (4) agricultural techniques, horticulture, forestry, stock breeding, fishery;
  - (5) treatment of diseases, preventive hygiene and pharmacy;
  - (6) ecology.

<sup>\*</sup> For the Republic of Kazakhstan it shall be applied not earlier than 2025 (unless otherwise stipulated by the liberalisation plans).

Note. The especially dangerous and technically complex projects of capital construction are:

- facilities for the use of nuclear energy (including nuclear installations, storage facilities for nuclear materials and radioactive substances, radioactive waste storage facilities);
- (2) thermal power plants with a capacity of 150 MW and higher;
- (3) subways;
- (4) aviation infrastructure facilities;
- (5) public transport infrastructure facilities;
- (6) hydro technical structures of I and II classes, established in accordance with the legislation of a member state of the Eurasian Economic Union on the safety of hydro technical structures;
- (7) transmission lines and other electric grid facilities with a voltage of 330 kV and more;
- (8) space infrastructure facilities;
- (9) seaports, with the exception of objects of seaport infrastructure, intended for parking and maintenance of small-sized, sport sailing and pleasure boats;
- (10) hazardous industrial facilities of I and II hazard classes, on which hazardous substances are produced, used, processed, formed, stored, transported, destroyed;
- (11) hazardous production facilities on which melts of ferrous and non-ferrous metals, alloys based on these melts are produced, transported and used by means of using equipment designed for a maximum melt quantity of 500 kg and more;

- (12) dangerous industrial facilities in which mining operations are carried out (with the exception of mining of common mineral resources and the development of placer mineral deposits that are carried out by the open method without the use of blasting operations), works on the enrichment of minerals;
- (13) main pipelines of oil, gas and oil products;
- (14) high pressure pipelines;
- (15) capital construction projects, in the design documentation of which at least one of the following characteristics is provided:

height of more than 100 meters;

spans of more than 100 meters;

the presence of a console of more than 20 meters;

penetration of the underground part (completely or partially) below the land planning mark by more than 15 meters.
