**ORDER**

CONTINUATION, THE CERTIFICATE OF CONTINUATION OF LEGAL PERSONS  
UNDERGOING RE-DOMICILIATION AND THAT OF THE STATEMENT OF  
INFORMATION ON THEIR BEING IN THE PROCESS OF RE-DOMICILIATION**

Guided by point 2 of part 2 of Article 13, Article 36.1 and part 1 of Article 36.3 of the Law of the Republic of Armenia "On state registration of legal persons, state record-registration of separated subdivisions, institutions of legal persons and individual entrepreneurs", as well as Articles 59.2 and 59.3 of the Civil Code of the Republic of Armenia,

**I hereby order to:**

1. Approve the form of the initial certificate of continuation of legal persons undergoing re-domiciliation, pursuant to Annex No 1.
2. Approve the form of the certificate of continuation of legal persons undergoing re-domiciliation, pursuant to Annex No 2.
3. Approve the form of the statement of information on legal persons, undergoing re-domiciliation, being in the process of re-domiciliation, pursuant to Annex No 3.
4. This Order shall enter into force on the tenth day following the day of its official promulgation.
