DECISION

No 1746-N of 24 December 2003

ON APPROVING THE CADASTRAL VALUATION PROCEDURE, THE COEFFICIENTS AND BOUNDARIES OF VALUATION ZONING OF TERRITORIES (LOCATIONS) OF RESIDENTIAL LANDS OF THE REPUBLIC OF ARMENIA

The Government of the Republic of Armenia hereby *decides:*

1. To approve:

(a) the cadastral valuation procedure for residential lands of the Republic of Armenia in accordance with Annex No 1;

(b) the coefficients and boundaries of valuation zoning of territories (locations) of residential lands of the Republic of Armenia in accordance with Annex No 2.

2. To define that:

(a) the base price per one square metre of residential lands of the Republic of Armenia shall be 60000.0 AMD;

(b) the cadastral valuation of residential lands located within the administrative borders of the communities of the Republic of Armenia, as well as of residential lands, designated for other purposes, of the land reserves, except for agricultural lands, shall be carried out according to the cadastral valuation procedure for residential lands and using the coefficients and boundaries of valuation zoning of territories (locations) of residential lands located within the administrative borders of the communities, approved by this decision (Annexes No 1 and No 2);

(c) the cadastral valuation of residential lands located beyond the administrative borders of the communities (within the marz borders) of the Republic of Armenia, as well as of residential lands, designated for other purposes, of the land reserves, except for agricultural lands, shall be carried out according to the cadastral valuation procedure for residential lands, approved by this decision, where for residential lands (except for lands allotted for construction and maintenance of public facilities), as well as for residential lands, designated for other purposes, of the land reserves (except for agricultural lands), the minimum coefficients of valuation zoning of territories (locations) of residential lands of the given marz shall be applied as coefficients of valuation zoning of territories (locations) of residential lands located within the administrative borders of the adjacent community (based on the shortest distance) shall be applied (Annex No 2);

(d) an additional reduction coefficient of 0.6 shall be applied to the cadastral prices of agricultural production facilities, such as cattle barns, stacking places, silo pits, etc., located within and beyond the administrative borders of the communities (within the marz borders) of the Republic of Armenia, except for lands allotted for construction and maintenance of processing facilities;

(e) for the purpose of calculating sale prices or minimum starting prices, but not for calculating the land tax, the cadastral prices of residential lands of the Republic of Armenia, calculated in accordance with the procedure of cadastral valuation of residential lands and using the coefficients of valuation zoning of territories (locations) and the prescribed base value, shall be considered as reference values in cases of alienation (through direct sale or auction, except for the lands within the development zone of the

Northern avenue approved by the Decision of the Government of the Republic of Armenia No 645 of 16 July 2001 "On measures for the development of the Northern avenue of Yerevan", which shall be calculated in accordance with cadastral values effective prior to the adoption of this decision) of state- or community-owned land parcels, as well as in cases of provision thereof under the right to lease;

(f) the average amounts of cadastral net income and cadastral value (provisional) and territory valuation zones of the city of Yerevan approved by the Decision of the Government of the Republic of Armenia No 462 of 28 September 1994 "On approving the provisional amounts of the cadastral net income and cadastral land values of residential lands (lands of cities, urban-type settlements, villages) of the Republic of Armenia", the amounts of the cadastral net income — as prescribed per communities and valuation regions — for smallholdings approved by point 1 of the Decision of the Government of the Republic of Armenia No 237 of 3 July 1997 "On approving data of state land cadastre relating to agricultural and unusable lands in the Republic of Armenia", the cadastral prices calculated according to the valuation procedure approved by the Decision of the Government of the Republic of Armenia No. 1101-N of 25 July 2002 "On approving the cadastral valuation procedure for lands allotted for public and manufacturing facilities and other agricultural land types (unusable) located within and beyond (for marzes) administrative borders of communities of the Republic of Armenia" shall be considered as reference values for the calculation of the land tax for land parcels considered taxable objects.

3. This Decision shall enter into force from 1 January 2014.

PROCEDURE

FOR CADASTRAL VALUATION OF RESIDENTIAL LANDS OF THE REPUBLIC OF ARMENIA

The cadastral price of residential lands of the Republic of Armenia shall be calculated using the following formulae:

CPland=Vbase x Aland x Zc

where

CPland is the cadastral price of the land parcel undergoing valuation, expressed in AMD;

Vbase is the base value of residential lands per one square metre, expressed in AMD;

Aland is the area of the land parcel, expressed in square metres;

Zc is the coefficient of valuation zoning of territories (locations) of residential lands.
